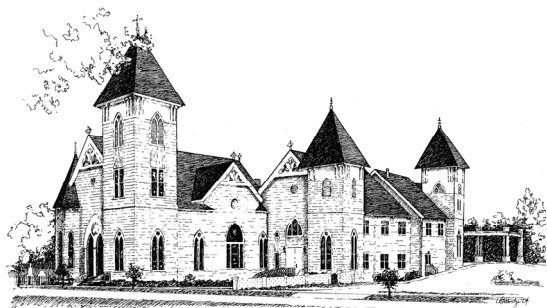

Monticello Presbyterian Church was founded May 30, 1829, by five founders who purchased the land on which the church still rests. The building we meet in today is the second sanctuary on this site, built in 1898 with additions built in 1928, 1952, and 1999.

Now more than ever, we are delighted to be partners with you, our siblings in Christ throughout Northeast Georgia Presbytery. The congregation wishes to express its gratitude for all of the prayers and support that you have offered as we continue to mourn the loss of our pastor, Rev. John Van Deventer.

As you make your plans to attend, we'd like to share some practicalities to make your visit with us as smooth as possible.

Accessibility and Parking – The church address is 246 East Washington Street. There is limited parking on the same level as the sanctuary, but there is a covered portico for drop-off and pickup, with access from East Washington Street. There are also spaces in the lower parking lot with access from South Street. Note that there is not an elevator from this level. When our spaces are full, our friends at Jordan Funeral Home (264 Hillsboro Street), have offered the use of their parking lot.

WiFi - The WiFi connection for the church is MPC, and the password is mpc31064. Connectivity is spotty throughout the building, but should be adequate in the sanctuary.

Live-Stream - The meeting will be live-streamed through the church's [YouTube channel](#) and [facebook](#) page. You'll be able to watch the meeting in real time, but will not be able to participate (voice and vote) in the meeting nor be recorded in the attendance.

Stated Clerk's Report
Rev. Ed Rees

At our August Presbytery meeting, the Administrative Commission for the Carnesville and Hopewell churches submitted a plan for the possible dissolution of the Hopewell congregation and the proposed transfer of that church property. After receiving feedback regarding that proposal, and after further conversations with the Hopewell congregation, the AC has elected to withdraw that report. Dialogue with the Hopewell congregation is continuing, and a report will be submitted to Presbytery at a later date.

It is common at this season of the year for congregations to hold officer elections and conduct training for those elected to serve as elders and deacons. Useful resources for this training can be found at a website maintained by the Synod of Mid America called Theocademy (<http://www.theocademy.com/>) There are training videos and discussion handouts available to facilitate the work of equipping those who are called into ordained service for their work. Additional resources are offered by our denomination through a program called Coming Alive in Christ, which is available at <https://equip.pcusa.org/course/index.php?categoryid=35>

In reflecting on our policy for speaking at Presbytery meetings, please remember that Commissioners have both voice and vote, and are encouraged to exercise both. If you have questions, please raise your hand to be recognized, and come to a microphone, identify yourself and your church, and fire away. Our best work is done when we all participate fully in collegial discussion and debate, seeking the Lord's will for our Presbytery.

POLICY REGARDING TIME LIMIT FOR PERSONS SPEAKING (Debate) AT PRESBYTERY MEETINGS

(Approved by Presbytery October 23, 2007)

(Note: Presbytery can set aside such a rule when it deems necessary.)

When speaking at a Presbytery meeting:

1. Individuals are limited to speaking once and for no more than three minutes during discussion of a matter.
2. A bell may be used to signal when the speaker is near and at the end of his/her time.
3. Moderator alternates between "pro" and "con".
4. No one may speak more than once until every person who wishes to speak has had a opportunity to do so.
5. Presbytery may set a maximum time for debating an issue.

2. Assist sessions with the annual review of installed, interim, and contract pastors.

These minimum standards are intended to apply to all full-time ministers who are members of Northeast Georgia Presbytery. The minimum standards should be prorated for part-time ministers.

Additional Information

- The Committee on Ministry conducts an Annual Salary Standards Review to ensure all pastors' compensation packages meet or exceed that year's minimum salary standards. Reporting forms are emailed to clerk so session each January, to be completed by March 31.
- The Board of Pensions provides a guide to structuring ministers' terms of call, *Living by the Gospel*, as well as a dues calculator on its website, www.pensions.org.
- Northeast Georgia Presbytery has adopted a Sabbatical Leave Policy. Please contact your Committee on Ministry liaison for more information.

Committee on Ministry Recommendations

- The Committee on Ministry recommends that the base minimum salary be increased by 1% for each year the minister has been ordained.
- The 223rd General Assembly of the PC(USA) appointed a task force to study, work, pray and discern on the issue of paid family leave for PC(USA) employees, including but not limited to ministers. The Committee on Ministry encourages church sessions to begin now to study, research, and prayerfully discern their own family leave policy.
- The Committee on Ministry strongly recommends that both churches and clergy take advantage of the resources offered by The Board of Pensions and its website (www.pensions.org). These resources include information about benefits selection and administration, tax questions, changes to healthcare, retirement planning, and much more.

Statement of Faith – John McCrosky

I believe in the one triune God: Creator, Christ, Holy Spirit—three distinct persons, yet one in essence and spirit. God creates all things for God’s own pleasure and goodness; is transcendent and majestic, having spoken worlds into existence; God is immanent and intimate, caring for all God’s beloved people in all aspects of life, time, and place. Before there was anything, God was: three-in-one in divine relationship, infinite and eternal, all-wise and powerful. God is the essence of radical love, from which we receive mercy though we deserve punishment; from which we receive grace though it is totally unmerited. In love, God covenants with humanity. God proclaims again and again, “You will be my people and I will be your God.”

Jesus, present and active in the creation of the cosmos is God’s only Son, Word incarnate, the New Covenant. Jesus came to live among us in full humanity and divinity. Born into a peasant family, lived under the harsh occupation of the Roman Empire, tempted as all humans are yet, Jesus was blameless. He taught a new way to follow God’s law, performed miracles, returned people to wholeness, and even raised the dead. In these acts, he threatened the status quo, suffered, and died on the cross still obedient to God’s will. Jesus rose from the dead, entered heaven, and is one with God. Jesus: a prophet, a teacher, the King of all kings. With all power and glory, he sits as judge over all creation. In fullness of compassion, he is the High Priest, interceding for us with the Triune God.

The Holy Spirit proceeds from God; active in creating the cosmos and is still active now. The Spirit calls us into a right relationship with God, each other, and creation; takes hearts of stone and turns them into hearts of compassion; unites us with Christ; calls us to vocations of justice and mercy.

God chose humans as God’s beloved. This act of election is about God’s steadfast faithfulness and love, not anything we have done or will do. Through Christ’s faithfulness even unto death and resurrection we are justified, sanctified, and called to serve him for the praise and glorification of God. In Christ, we are offered new life and called into ministry with the saints of the church to help bring about God’s beloved community.

Baptism and The Lord’s Supper are physical signs of the New Covenant. They remind us of God’s steadfast love and desire to be in an intimate relationship with each of us, and that we are called to live in kinship with one another. I believe that the Bible is the inspired, infallible Word of God, offered as revelation and truth. The truth and authority of the scriptures are revealed to us by the Holy Spirit, again and again, each time in new ways. I believe the church is Christ’s Body, inaugurated by God and commissioned by the Holy Spirit to do God’s work on earth. The church exists to worship and praise God, serve with compassion paying special attention to the marginalized and forgotten, and to make disciples of all people.

Statement of Faith Journey – John McCrosky

In pondering the many experiences growing up in the church I am grateful for a number of wonderful models of pastoral care. These experiences not only shaped an understanding of my importance as a child of God but also my value within the faith community. It all started when I was baptized as an infant and spent countless hours in the church nursery with Miss Dorothy who was always ready to receive me into her embrace each time she saw me. When I was too old to be in the nursery, I would often find my way back, if for nothing else then for that reassuring hug that I could always count on.

As I grew, I would get to know others in my church that would be just as warm and accepting of me whether it be in Sunday school, vacation bible school, those sitting around me in worship, or other adults who would always greet and welcome me with a sense of joy. The church was always a place where I knew I belonged and was loved, no matter what.

One of the most vivid memories of my childhood was during middle school. The pastor of my church invited me to join him on his boat for an afternoon of sailing. As a middle schooler, I was struggling with my self-identity, and I truly believed that no one cared about me. But when I found out that not only was I invited to go sailing with my pastor, but that he wanted to take me, and no-one else out on the lake, that I would have his undivided attention, it was literally life changing. We spent about two hours out on the water. I don't remember anything we talked about, but I do remember is the feeling that someone important to me cared for me and wanted to spend time with me.

This type of relational ministry has been central to how I have understood what pastoral care was because these were the times I felt most connected and supported in my faith journey. Spending one-on-one time with our pastor, youth worker or other church members during my youth was central to realizing that someone cared to be with me. In college, I sought out the Presbyterian campus ministries and received much needed pastoral care for the campus ministers and other students in the ministries. Over the past 25 years, I have tried to focus my ministry building similar meaningful relationships with the youth and children. I have also tried to teach and create space for peer-to-peer pastoral relationships. Whenever I could, I would remind the church leaders and other adult members of the promises we reaffirm at each baptism: to nurture the children in their faith. I encourage them to become engaged in the lives of the young people - calling them by name, going to their performances, asking them, often about their lives and sharing what is going on with themselves.

When I look at the life and ministry of Jesus, I reflect on how he was intentionally and fully present for each person he met. Jesus took the time to attend to the lives of those who were cast aside by society. He met the Samaritan woman at the well and gave her hope (John 4:4-49), he dined with Zacchaeus, the tax collector (Luke 19:1-10), and when the Pharisees complained that Jesus eats with tax collectors and sinners, Jesus tells them that "healthy people don't need a physician, but sick ones do. I did not come to call righteous people, but sinners" (Mark 2:15-17).

Jesus spent enormous energy caring for those who lived on the margins of society to give them hope and to bring reconciliation to their lives. He gave them what they needed to make their own choices but did not make the choices for them. He knew that each person had to do the work needed to turn their lives around, however, he gave them the path. What I find life-giving in these stories of Jesus is that he was able to self-differentiate the needs and desires of those he cared for without falling into the unsustainable practices of taking care of people. This is a practice that is very difficult to master, yet something I believe is essential to pastoral ministry. I have experienced this kind of care in my life through so many people: Sunday school teachers, youth advisors, camp counselors, scout leaders, parents of friends, teachers, family members, bosses and co-workers, youth and children, even those living on the margins of society. It always amazes me when I experience the work of the Holy Spirit in my life through those with whom I encounter each day. Each time I am reminded that is precisely how God works: through the lives of God's beloved.

Written Report of General Presbyter Rev. Hilary Shuford
To Northeast Georgia Presbytery's 115th Stated Meeting
October 25, 2022 at Monticello Presbyterian Church

During my remarks on the floor at our next Presbytery meeting I will share some personal stories of my renewing and restful time away with God while on sabbatical. I am reporting here on my activities since returning September 1. My husband Harry has characterized my re-entry among you as “jumping back into the river with both legs.” A bit more true to my feeling and thinking is that God transformed me during my sabbatical, grabbed me by the scruff of the neck and threw me “with all four paws” back into the river of life and work in Northeast Georgia Presbytery. These past 6 weeks have been full of love and energy.

My work began with meetings (in person and by telephone) with staff, officers, and leaders, specifically Anita, Ed, Andy, Sylvia, Mari, and Frank, and with committees and leadership of Committees on Ministry, Preparation for Ministry, Nominations, Representation, Congregational Connections, Clergy Care, Personnel, Budget Finance, Coordinating Team, and Property Commission. Also the 3rd Thursday book study (open to everyone) was a highlight of my return. I celebrate your collegiality and dedication to being the best and most healthy presbytery imaginable! I was thrilled when I viewed the work of Northeast Georgia Presbytery at the August meeting: I am so proud of you!

Since returning I communicated with teaching and ruling elders in 33 of our 48 congregations, including the Presbyterian Campus Ministry at the PSC and The Backyard Ministry NWC. Please remember all our pastors and gathered worshiping communities are in need of our prayers, especially our 5 congregations with pastor nominating committees. And as the Session of Trinity Presbyterian in Gainesville has requested the presbytery to dissolve the congregation and disburse the assets, several conversations are emerging related to planting new worshiping communities within our bounds.

By the time you receive and read this report you will have learned of the passing of Frank Colladay on Saturday October 15 in Dahlonega. Frank was serving God's people the day he died: he was preparing to conduct a wedding ceremony. He will be deeply missed by all who knew him, because he loved everyone he met. I was planning on celebrating his leadership October 25 in Monticello because it was Frank who called me in early 2021 as he entered into the office of Moderator (for the 3rd time) and told me his mission was to get every church in Northeast Georgia Presbytery to join the Matthew 25 Initiative. And then about 6 months later Frank told me that he wanted the Presbytery to have an overnight retreat. I thank God for the love, dedication, and leadership of Frank Colladay who has joined the saints praising God forever!

We do grieve as we let go, but not without hope; and as we look forward to our future, we remember Jesus' words to his disciples, which includes us, “...you will receive power when the Holy Spirit has come upon you; and you will be my witnesses in Jerusalem, in all of Judaea and Samaria, and to the ends of the earth” (Acts 1.8). We are encouraged when we think of the saints who have gone before us as we continue to support our ministries and mission within and outside our bounds. Please take time to review the reports in this handbook, including the letters from Rev. Cheryl Barnes our mission co-worker and education facilitator in Malawi, Zambia, and Zimbabwe.

We will be blessed to be with each other again as we gather in Monticello as we hear the Word proclaimed and described by all who address the gathered body that day. Praying safe travels for everyone.

6. Heard a report from BFIT and the Treasurer.
7. Discussed the speaker for the February 2023 Presbytery Meeting.

Actions:

1. Approved the minutes of the July 28, 2022, meeting.
2. Endorsed the Sexual Misconduct Pastoral Response Committee's Recommendation that Northeast Georgia Presbytery mandate every minister member and everyone supplying a pulpit or engaged in pastoral ministry to complete the Darkness to Light: Stewards of Children child abuse prevention training by June 30, 2023.
3. Approved the designation of the money received at the October Presbytery Meeting go to The Backyard Ministry.
4. Approved request of the Administrative Personnel Association membership chairperson to share the directory of Presbytery support personnel.
5. Appointed Lee Koontz to the Personnel Action Team for the class of 2025, reelected Marie Powell for a second term expiring in 2025, and reappointed Paul Evans as chair of the Personnel Action Team.
6. Approved a grant request from Connectional Events Superfund of \$60 per attendee, up to \$6,000, for a presbytery-wide youth retreat to Epworth-by-the-Sea on October 21-23.
7. Made changes to the proposed budget for 2023.
8. Established dates for the 2023 Coordinating Team meetings.

Sexual Misconduct Pastoral Response Team

The SMPRT met via email to discuss and approve upcoming mandatory training for all minister members of Northeast Georgia Presbytery and anyone who wishes to fill pulpits during the next 3 years. Darkness to Light's Stewards of Children online training was approved by the team due to the continued need of our churches to stay vigilant in the safety of all its members, especially the most vulnerable, children and persons with disabilities. As their website states, "Darkness to Light offers training that specializes in the education and prevention of child sexual abuse, other forms of abuse, and mandated reporting." The online format will allow participants to take the two-hour training on their own schedule and at their own pace. The flexibility this style of training allows, we are hoping, will lead to near 100% participation by the presbytery. There is a virtual option that is available if there are those who would rather take the training with a facilitator in a ZOOM-like format with a larger group.

We understand this training was offered 6 years ago, and much will seem repetitive, but we feel strongly that we all need to stay sharp to keep our members safe. Upon completion of the online training, each participant should forward a copy of their certificate to pastorfpcornelia@gmail.com (Rev. Andy Chambers, FPC Cornelia, Chair SMPRT). For more information, please also contact Rev. Chambers. More information will be forthcoming on this mandatory training which is to be completed by June 30, 2023.

We submit this report as a recommendation to the Northeast GA Presbytery to mandate that every minister member and everyone supplying a pulpit or engaged in pastoral ministry complete the Darkness to Light: Stewards of Children child abuse prevention training by June 30, 2023.

Report from the Church Property Commission: October 12, 2022

re: Presbyterian Student Center at UGA

On October 4, 2022, the Property Commission received a request from The Board of Directors of Presbyterian Campus Ministry, Inc. (“PCM”), asking the Property Commission to review and approve its request to obtain a loan from the Presbyterian Investment & Loan Program (“PILP”) in an amount up to \$180,000 with the funds to be used to replace some very old HVAC equipment and upgrade the electrical system at the Presbyterian Student Center (“PSC”) on the campus of the University of Georgia in Athens. Upon review, the Property Commission by majority vote (5 in favor and 3 not voting) hereby recommends the Presbytery approve the request.

Attachments: Attached to the email you are receiving are copies of this Report, the Letter of Request from the Board of Directors, and the Loan Application to PILP, which are incorporated and made a part of this Report by reference.

Additional Information: Provided by Rev. Will Norman:

1) The current HVAC and electrical systems are very old and inefficient. The boiler, air handler, and main electrical panel are original to the 1959 building, and the outdoor unit is probably from the 1980's. For many years now (and since before my time) PSC has been counseled by service folks that the units were on their last legs and would need to be replaced.

2) PSC first obtained a bid for this work some 10 years ago. The bid price was \$300,000, but it was from a large commercial HVAC company, Batchelor & Kimble. They knew their price would be higher than smaller companies would offer and advised the board at that time to take a different route. More recently (in my time) we had bids on a larger renovation, which included line items for the HVAC & Electrical, which ranged from \$214,000 to \$300,000. This work is limited to the HVAC and electrical systems.

3) The new systems will be much more energy efficient. The new units and accompanying smart thermostats will effect a significant reduction to the PSC's environmental impact as well as our energy and natural gas expenses.

4) The contractor, Superior Air Management (“SAM”), has worked with and for PCM board member and longtime Athens building and construction veteran Smith Wilson for a number of years. In addition to being the low bid, that personal relationship gives us confidence that SAM will be a reliable, committed and capable contractor for the job.

5) PCM has received several substantial pledges and gifts from individual donors and local and family foundations. \$37,500 has already been collected; \$177,500 is pledged by 21 donors over the next 3 - 5 years; and NEGA Presbytery is proposing (not yet approved) to contribute \$35,000. We have received other smaller gifts ranging from \$2,500 down to \$100, some paid in full, and some pledged. So far the pledges, gifts, and proposed NEGA Presbytery gifts total more than \$250,000 - well above the requested maximum loan amount of \$180,000.

6) We expect the loan interest rate to be about 3.5% (this is PILP's creation care loan rate). We are planning to take a 5 year repayment term, but are very confident we will pay off the loan early. But if taking the full five years (60 months), the monthly payment on the \$172,400 loan (as requested in the loan application) would be \$3,136.26; total interest paid over 5 years would be \$15,775.41; and the total of 60 payments would be \$188,175.41.

7) As of October 5, we have \$32,857 in our capital campaign account. Pledges payable in 2022 currently total over \$43,700. We fully expect both to grow significantly over the next three months. The loan payments should begin in February 2023, requiring \$34,499 to pay the minimum required payment for year 2023. So, the first year is almost covered with the funds we have on hand.

8) This property is not subject to any other encumbrances. This would be the only debt.

The Property Commission is in favor of granting this request.

The Backyard Ministry Report
Rev. Souvanh Touralack, Evangelist

The Backyard Ministry is continuing to serve the Lao community and beyond. As for the focus of the Ministry to the Lao community. We are dividing it into two parts. One part is that I, the Pastor, speak English and Lao that I minister to second-generation American who only speak English. John focuses on the first generation who speaks Lao and understands little English. John is my father who makes his visit according to his time and schedule. He took them food during the distribution and invited them to Sunday class and church service. As for me, I teach Lao Sunday class, do Lao sermon, do home visits, invite new families to Christ, serve communion with Rev. Andy Chambers, and record Lao worship on the Backyard Ministry website. Furthermore, I volunteer with food distribution when it is possible.

Moreover, I have applied for the 2nd grant from 1001 New Worshiping Communities, a \$30,000 Investment Grant, which is being reviewed now, and we will know more by the end of October. Part of the requirement is that I attend coaching sessions twice a month, the first and third Friday of each month, from 3:30 to 5:30 PM.

Laos' culture is unique. It isn't accessible to penetrate a challenging Buddhism religion. In Lao's culture, there is no Jesus Christ or Christians beliefs mentioned in the society. It is challenging to convert Buddhism beliefs to Christianity. It is more complex to fulfill Matthew 28 because it takes time to educate and ask them to trust in Christianity. To introduce the Lao community to Christ, the Backyard Ministry invites the Lao community for special events like Lao's New Year and Christmas luncheon. There are usually thirty to forty people for each of these events. We believe this is a great way to let the Lao community know we exist and are willing to help.

Since the Backyard Ministry was established in 2019 to 2022, the Backyard Ministry and the First Presbyterian Church of Cornelia baptized eight people. Among these eight people, there were five adults and three teenagers.

There are many events that are captured in the Backyard Ministry Facebook page. Please visit it. I want to take this opportunity to say thank you to the Northeast Georgia Presbytery in advance. May God continue to bless each of you for serving His Ministry. Your hard work is appreciated by the Backyard Ministry.

Report for NEGA Presbytery
Rev. Cheryl Barnes, Mission Co-Worker

Greetings friends,

I am honored to share with you some recent updates from my ongoing work with the Church of Central Africa Presbyterian (CCAP) as an Education Facilitator for the Synods in Malawi, Zambia, and Zimbabwe. This year has allowed the opportunity for travel to the US and visits to the Synods that I partner with in Malawi due to the loosening of travel restrictions by Presbyterian World Mission.

In January, I joined Gainesville First Presbyterian Church for their World Mission Conference. The conference was well planned and successfully executed. It was at this conference that I met Anne Hallum the founder of Alliance for International Reforestation, Inc. (AIR). As a result of this contact, the CCAP has entered into a successful collaboration to begin a Tree Nursery Project to benefit the CCAP schools and Women's Department. This project has potential to become income generating, while also providing solutions to climate change and soil erosion. The Tree Nursery Project began in early May and the seedlings will be ready to transplant in the coming rainy season, December - February.

While in the US, I also participated in virtual Bible Study with Reconciliation International Ministries and made a presentation to the Mountain View Presbyterian Church in Loveland Colorado. I also participated in an Epiphany Service for Presbyterian World Mission.

In March, I traveled with the Secretary General of the CCAP to visit the Synods of Livingstonia and Blyantre. I met with the Education Directors and was able to gain valuable information on how to support and partner with their visions for improving the quality of education in their Synods.

On November 24, 2021, the CCAP General Assembly received a donation from NEGA Presbytery for the Educate Our Girls Project (EOG) in the amount of \$2,905.00. (EX 815.29 = 2,368,417.45 Malawi Kwacha). This amount includes the standard deduction of 17% by PCUSA for administration costs. During the month of May, the donated funds for the Educate Our Girls (EOG) project were distributed to 3 Synods; Livingstonia, Blantyre, and the Synod of Zambia. 52 girls were selected to receive the scholarships. Each recipient received a scholarship of 45,000 MK to continue their education for one year. The Synods of Livingstonia and Blantyre received 900,000 Malawi Kwacha for scholarships for 20 girls per Synod and 9,5000 MK for administration costs. The Synod of Zambia received 11,763.36 Zambia Kwacha, (equal to 900,000 MK) for scholarships for 12 girls and 180.92 ZMW, (equal to 9,500 MK), for administration costs. Administrative costs include bank fees and transportation costs to deliver the funds to the schools.

In June, I presented a virtual interactive training on the topic, *The Classroom Environment*. There were four main objectives for the training which included:

- > Introduction of teaching methods and instructional materials that enhance student development.
- > Demonstrating ideas for teacher made instructional aids utilizing recyclable items that enhance the classroom environment.
- > Offering ideas that encourage student participation and provide opportunities for individualized learning.
- > Presenting options for creating a learning environment that is attractive, stimulating, safe, and student centered.

From June 23- 29th, I again traveled to the US for the wonderful opportunity to serve the 225 General Assembly as Mission Advisory Delegate (MAD) on the Race, Gender and Justice Committee. I continued my work with GA via Zoom with the plenary sessions July 5th – July 9th. It was an historic General Assembly, and I was grateful to participate in service to our denomination. I am currently working on forming a new partnership with the CCAP and a South African based organization called “Valuable to Jesus.” This organization focuses on identifying and addressing the trauma of sexual abuse among children. This partnership will be a joint effort with the goal of sharing a six-point interactive instructional program that includes visual aids, artwork, doll making patterns, song lyrics and other teaching tools necessary for fully bringing the message of the harmful effects of sexual abuse, prostitution and pornography directed towards primary age school children. The “Valuable to Jesus” program will be implemented in the 5 Synods under the CCAP umbrella.

I continue to give thanks to God for empowering me to do this work. I am also very grateful for the financial support and the prayers that you are sending on my behalf. We are never asked to do this difficult work alone, it takes each of us coming together, in order for us to realize that our small efforts can have tremendous effect.
