Ficklen Church Administrative Commission

Final Report to Presbytery

At the February meeting of Presbytery, approval was given for the sale of the Ficklen Church property to Angel Band Ministries, Inc., for \$25,000.00. On May 31st, 2023, the sale was concluded, and the proceeds were forwarded to the Presbytery office. In keeping with Presbytery policy, 25% of the proceeds were transferred to the Georgia Domestic Missionary Society, and any remaining expenses related to the property were also paid. As previously approved by Presbytery, the remaining balance of \$24,637.68 was transferred to The Backyard Ministry, Cornelia Georgia.

This concludes the work of the Ficklen Church Administrative Commission.

Stated Clerk's Report

As you are probably aware, all of the thirty-three amendments to the Book of Order that were proposed by the last General Assembly passed and became effective on July 9, 2023. As a result, a number of actions are necessary for implementing these changes. These are summarized as follows:

Amendments: 22-I (G.2.0804); 22-Q (G-3.0303c)

Terms of call must now include at least 12 weeks of paid family leave. The GA has defined "family leave" to include at least the following:

- -to accommodate the birth, foster placement, or adoption of a child.
- -to provide care for an ill or disabled family member.
- -to provide time for healing following a loss or tragic event.

In addition, presbytery minimum compensation standards must include provision for terms when a relationship is dissolved, and there must be minimums both for called and installed pastors, temporary pastors, and certified educators.

Amendments: 22-G (G-2.0603); 22-K (G-2.1002); 22-L (G-2.1103); 22-O (G-3.0106); 22-P (G.3.0106) All councils must include boundary training requirements for their members. Each presbytery will determine what training meets these requirements. In addition to teaching elders, boundary training is now required for commissioned ruling elders, inquirers, certified Christian educators, and certified associate Christian educators.

All councils shall adopt and implement a sexual misconduct policy, a harassment policy, a child protection policy, and an anti-racism policy.

Amendments: 22-C (G-1.0501); 22-M (G-3.0104); 22-N (G-3.0105)

Roberts' Rules of Order, Newly Revised, is to be utilized as the parliamentary authority in all council bylaws, unless another authority is specifically designated. Congregations, Sessions, Presbyteries, and Synods *should* (not an absolute requirement) adopt rules governing electronic meetings if the choice is made to conduct such meetings.

Amendment: 22-F (G-2.0505a(1))

On receiving ministers for immigrant fellowships, provision is to be made for lifting up consultation with those communities and for appropriate educational opportunities.

The Darkness to Light/Stewards of Children training was offered and completed by the preponderant majority of pastors, both active and retired. Certain individuals whose training was not completed by the July 31st deadline have been advised that they are ineligible to carry out any pastoral functions until confirmation of the training has been received.

The report of the Administrative Commission for the Installation of Rev. Steven Barnes as Pastor of Oconee Presbyterian Church, effective June 25, 2023, was received and the Commission is dismissed with gratitude.

All Clerks of Session need to complete the annual Session minute review. Please partner with another church to exchange records and document your findings, utilizing the checklist and review form found on the Presbytery website under "Resources, Clerks of Session." If you need assistance in this, please let me know.

Rules for Debate:

(Approved by Presbytery October 23, 2007)

(Note: Presbytery can set aside such a rule when it deems necessary.)

When speaking at a Presbytery meeting:

- 1. Individuals are limited to speaking once and for no more than three minutes during discussion of a matter.
- 2. A bell may be used to signal when the speaker is near and at the end of his/her time.

- 3. Moderator alternates between "pro" and "con".
 4. No one may speak more than once until every person who wishes to speak has had an opportunity to do so.
- 5. Presbytery may set a maximum time for debating an issue.

Statement of Faith Greg Loskoski

I believe we live in a fallen and broken world. Isaiah 60:2 says, "See, darkness covers the earth and thick darkness is over the people." That seems to me to be a fair assessment of life in our modern world. However, the first thing that we learn about God in Genesis 1 is that "the Spirit of God hovered over the darkness and God said, 'Let there be light." When Isaiah speaks of the darkness that covers the people, he continues with these words "Arise, shine, for your light has come, and the glory of the Lord rises upon you, and his glory appears over you. Nations will come to your light."

We hear a lot these days about being "enlightened" and there are a lot of voices claiming to represent enlightenment. Scripture is clear (John 1): "The true light that gives light to everyone was coming into the world. In him was life, and that life was the light of all mankind. The light shines in the darkness." I grew up in the PCUS. Those with similar background will remember "Lux Lucet en Tenebris" (Light shining in darkness) the motto of that denomination. I believe that light and life are found in the person of Jesus Christ. The church is called to follow Christ into a fallen world with a message of life and hope.

I subscribe to the tenets of the Protestant Reformation commonly referred to as the Five Solas: sola Scriptura (Scripture alone), solus Christus (Christ alone), sola fide (faith alone), sola gratia (grace alone), and soli Deo gloria (glory to God alone). All that we know about God, or can know, is that which God has revealed to us. That revelation comes to us in two forms: Scripture and the person of Jesus Christ. Our salvation is found through the grace of God alone. No human work can merit our salvation. Salvation is offered only through the saving work of Jesus Christ in our behalf. That grace from God is imparted to us through our faith in Jesus Christ. To the glory of God alone.

Being the recipients of such grace calls us into the world as ambassadors of a holy kingdom: "But you are a chosen people, a royal priesthood, a holy nation, God's special possession, that you may declare the praises of him who called you out of darkness into his wonderful light" (1Peter 2:9). New Testament Christianity is not primarily defined by adherence to a particular theological system, but by the indwelling of the Spirit of Christ (the Holy Spirit) which makes us "new creations" able to live and work in this world while not being of this world. The Gospel of Jesus Christ is unlike any message the world has to offer. Jesus Christ pushes back the darkness that seems to be so much a part of our human experience and allows light and life to become reality not only for us, but for our world.

Statement of Faith Journey Greg Loskoski

The Apostle Paul described my own faith journey when he wrote to Timothy about the faith he first saw in Timothy's grandmother and Timothy's mother. My grandmother lived with us, and bedtime stories were read from the Bible. My mother taught the Sunday School classes I attended as a child. If the doors of Midway Presbyterian Church in Anderson, South Carolina were opened for any reason, we were there. My father was an Elder and the church was an important part of our lives. I attended Presbyterian College in Clinton, South Carolina and Columbia Theological Seminary in Decatur, Georgia. Following graduation from seminary I was ordained as Associate Pastor of First Presbyterian Church, Valdosta, Ga. I served congregations in Leesburg, Ga. and Spartanburg, S.C.

In 1990 I became pastor of Flemington Presbyterian Church in Hinesville, Ga and served there until my retirement on April 30, 2023 at which time Ellen, my wife, and I moved to Blairsville, Ga. We have four grown children. I remember my faith journey in terms of the people God placed in my path who were instrumental in shaping my Christian walk. Some of those people have been life-long sources of inspiration, others maybe just a once in a life-time meeting.

Since 1998 I have been a volunteer chaplain with law enforcement. I serve the Georgia State Patrol, the Georgia Bureau of Investigation and the Department of Natural Resources. A lot of that work involves victim assistance and delivering death notifications. It also includes ministry to law enforcement officers and families. I also helped coordinate the jail ministry for the Liberty County (Ga) Sheriff's Office. Flemington Presbyterian Church adopted those ministries as part of the church's mission and allowed me the time to respond to those in crisis.

The lead singer of the British rock group, Bono, made a statement of faith that closely follows my own belief:

"It's a mind-blowing concept that the God who created the Universe might be looking for company, a real relationship with people, but the thing that keeps me on my knees is the difference between Grace and Karma... You see, at the center of all religions is the idea of Karma. You know, what you put out comes back to you; an eye for an eye, a tooth for a tooth, or in physics – in physical laws – every action is met by an equal or opposite one. And yet, along comes this idea called Grace to upend all that 'As you reap, so will you sow' stuff. Grace defies reason and logic. Love interrupts, if you like, the consequences of your actions. It doesn't excuse my mistakes, but I'm holding out for Grace. I'm holding out that Jesus took my sins onto the Cross because I know who I am. The point of the death of Christ is that Christ took on the sins of the world so that what we put out did not come back to us, and that our sinful nature does not reap the obvious death. That's the point. It should keep us humbled ... it's not our own good works that get through the gates of heaven ... If only we could be a bit more like Him, the world would be transformed."



Report of the Coordinating Team

The Coordinating Team (CT) met on July 25, 2023 via Zoom. They took the following actions and are making the following recommendations to presbytery:

For Information:

- 1. Heard reports from its Action Teams, the Stated Clerk, the General Presbyter, and several Presbytery Committees
- 2. Spent time in remembrance of Elder Michael "Cowboy Mike" Searles who passed away in June
- 3. Discussed upcoming needs for candidates to serve on the Presbytery's Nominating Committee when three members rotate off at year end
- 4. Reviewed Book of Order revisions requiring action by Councils

Actions:

- 1. Approved the minutes of the April 25, 2023 meeting
- 2. Authorized the Stated Clerk and Moderator to finalize the docket for the August Stated Meeting
- 3. Approved an offering at the August Stated Meeting for the Presbyterian Student Center at UGA
- 4. Approved a \$2,572 grant from the Assistance Fund
- 5. Granted permission for staff to go over budgeted amounts for professional expenses for this fiscal year, in light of increased travel requirements and an unanticipated increase in the IRS mileage reimbursement rate
- 6. Requested that an update on the progress and activity of the V26 Collaborative be provided at the August Presbytery meeting.
- 7. Approved the formation of a task force to further explore a proposal (attached) to purchase a cottage from William Black Lodge at Montreat, and to dialog with the Board of Directors of William Black Lodge
- 8. Confirmed the next meeting for September 26, 2023, at 10:00 a.m. at FPC Greensboro

Recommendations:

1. That the following dates be approved for 2024 Stated Meetings of Presbytery:

Proposal for the Frank Colladay Cottage

As board member of the William Black Lodge (WBL) in Montreat, NC and the treasurer of Northeast Georgia Presbytery (NEGP), I see an opportunity for these two organizations that I serve to mutually benefit from a partnership.

William Black Lodge is a three-story lodge with 25 guest rooms on North Carolina Terrace in Montreat, NC. Adjacent to the lodge, but fronting on West Virginia Terrace, WBL owns a small cottage that is lovely, but somewhat burdensome (for pictures, please visit https://williamblacklodge.org/cottage.html) It doesn't produce the level of income that the rest of the lodge produces, which makes it difficult to justify the expense of maintaining it. Ideas of mothballing it or selling it have been floated among the board, but others do not want to let go of it. This is an ongoing challenge for WBL.

At the same time, Northeast Georgia Presbytery has a potentially related challenge with an account at the Presbyterian Foundation called the *Retreat Endowment Fund*. This fund has its origins with a presbytery capital campaign in the early 1980s, which had the purchase of a retreat center as one of its stated goals. In the late 1990s, the presbytery invested these funds with the Presbyterian Foundation and the funds became restricted to the purchase of buildings or property for a retreat center. At the end of the first quarter of 2023, these funds totaled approximately \$168,000. This amount is probably not enough to ever purchase land or build a retreat center, let alone maintain it. As far as I could see, this money looked like it would never be able to be utilized and would remain with the Foundation in perpetuity.

WBL and NEGP both have challenges here that could be overcome by the other organization. WBL has a building that doesn't make economic sense to utilize, and NEGP has funds that are nearly impossible to utilize. A partnership between these organizations might allow us both to be better stewards of all that God has given us.

As a member of both organizations, it has occurred to me that it might make more sense for WBL to sell the cottage to NEGP for the full amount of the Retreat Endowment Fund, but for WBL to keep the land beneath it (a ground lease). WBL could maintain the

property, including all capital expenditures, in exchange for the revenue generated from it. NEGP could have free access to the property for a set number of days each year (perhaps 30 days), which they could give to their clergy for retreats.

If this partnership were to happen, then it would be appropriate to rename this cottage the Frank Colladay Cottage since Frank was such a beloved presence in both NEGP and at Montreat. I believe that the members of NEGP would be grateful for the chance to remember Frank in this way and to be able to enjoy a retreat center named for him.

This would benefit WBL with an infusion of funds into this cottage and the publicity of their ministry among the members of a presbytery with which it does not have a historical or formal connection. It would also fit well with WBL's historical mission to provide a place of retreat and renewal for persons serving in professional and avocational ministries.

I spoke with a few leaders from both NEGP and WBL in late 2022, and I found enthusiastic responses from both. I contacted Robert Hay at the Presbyterian Foundation to ask if this might be feasible, and he said that it was, though it would require a special review by a committee at the Foundation. In February 2023, I officially brought it to the Board of Directors at WBL. At the May 2023 board meeting, the board voted to invite NEGP to make a proposal. I took responsibility for formally communicating this action to NEGP on behalf of WBL.

As a member of NEGP, I am glad that we have the opportunity to craft this proposal rather than receive it. I think that it would be wise to bring this to the attention of the Coordinating Team on July 25 and the Church Property Commission. If we decide that we would like to explore this further, then I think that it might also be wise to hire a real estate attorney in Buncombe County, NC to advise us along the way and to help us close what would be an unusual real estate transaction.

At the same time, I would respect members of NEGP who thought that this may not be the best use of the Retreat Endowment Fund. I acknowledge that I have a conflict of interest, and I may not be able to see the interests of one organization apart from the other. I am happy to put it into the hands of the leaders of Northeast Georgia Presbytery and to follow their lead as we attempt to be wise stewards of God's gifts.

Report to Northeast Georgia Presbytery August 2023 Stated Meeting

When I returned from sabbatical a year ago, at the end of August, I made 2 resolutions: to continue with my new spiritual practices of breath prayer, and to encourage the Presbytery to begin a visioning process. As I reflected on these two directions, I remain thankful to God for the opportunity to serve with all of you in NEGP. I have continued with my new practice which has been renewing. The vision (V26) collaborative has begun its work, and Will Norman will be giving regular reports to you.

I want to thank everyone who reads my written reports and all the reports contained in the Presbytery meeting Handbook, and who attend to the matters placed before the body on the docket. And I want to remind you of the wealth of information found on the Presbytery's website, negaphy.org.

As an update on some pastoral concerns, I am asking for your continued prayers for Travis Adams, who has another week in the in-patient rehabilitation at Northeast Georgia Medical Center in Gainesville. I was informed yesterday that he can have visitors from 8am-4pm. We continue to celebrate the baby daughter of Dana Waters and the new hip of Mike Williams. I ask your prayers for all in our midst who are seeking to discern God's will and for all who are facing uncertainty and struggles in mind, spirit, and body. I continue praying for people who live in the war-torn country of Ukraine and for all who suffer from natural disaster, especially the citizens of the beautiful State of Hawaii.

My activities since our last meeting in May include resourcing committee meetings, having coffees, and lots of conversations with minister members and ruling elder committee members, training and supporting several congregational Pastor Nominating Committees, preaching, bring greetings and visiting congregations. I was so glad to be able to join with the other presbyters in the Synod of South Atlantic at the home of our Synod Exec Valerie Young in Jacksonville. We also have regular monthly zoom meetings but have not been together in person since before COVID. And I was able to take a week away with Harry this summer. Last week I began an intensive study of Bowen family systems theory as preparation for an 8-month course participating in the Bowen Center's Faith Leadership Seminar beginning Monday August 28 and continuing the last Monday of every month (except December and Holy Week).

Finally, last month I shared with the Coordinating Team (CT) what I have found to be a useful model about its (CT's) role in the presbytery structure. I like to think of a presbytery as if it were a tree, with branches and limbs representing the committees, teams, task forces. At the end of the branches are fruit-bearing clusters and flowers which represent the congregations ("leaves that do not wither," Psalm 1, "I am the vine and you are the branches" John 15, "rooted and grounded in God's love, Ephesians 2). And like the trunk of a tree, the CT is responsible generally for its CARE, coordination/communication, administration, review and evaluation. Moreover, the Presbytery is responsible for both planting seeds, nourishing those seeds, and being good dirt like in the parable of the sower (Matthew 13).

I look forward to seeing you on Zoom Saturday August 26, then in person on Saturday October 14 at FPC Athens for the social justice symposium and on Tuesday October 24 at FPC Cornelia.



Trinity Church Administrative Commission

In accord with the wishes of the congregation of Trinity Church, and in keeping with the prior approval of Presbytery, a final worship service to close Trinity Church was held June 25th, 2023. Rev. Travis Adams and Elder Susan Biddy, both members of the Trinity AC, were present for the service, which focused on giving thanks to God for the faithful work of the congregation for the past one hundred years.

The remaining financial assets of the church were transferred to Northeast Georgia Presbytery, and an appraisal of the property was obtained that indicated a fair market value of \$1.3 million dollars. A local realtor, Brent Hoffman with Berkshire Hathaway, was engaged to list the property for sale, and on July 26th a valid contract offering \$1.325 million dollars for the property was received. The contract has been reviewed by legal counsel and by the Church Property Commission, and the Trinity AC has unanimously agreed to **recommend that Presbytery approve the contract**. If approved, closing is set for October 24th, 2023.

Per Presbytery policy, 25% of the proceeds of any sale would be transferred to the Georgia Domestic Missionary Society, and any remaining expenses related to Trinity Church would also be drawn from this source. The congregation of Trinity Church expressed a strong desire that serious consideration be given to using some portion of the funds for the purpose of new church development in Hall County, Georgia. The Trinity AC concurs with that request, but is aware that Presbytery may determine that there are additional purposes to which these funds could be assigned.

Report to the Northeast Georgia Presbytery August 2023

In August, PCM welcomed two new student representatives to the board of directors: Jordan Farr, President of our student organization, and Jonathon Jones, Student Minister and member of Madison Presbyterian Church

The program year kicked off Tuesday August 15th with our weekly Word+Table service. As a reminder, worship is always open to anyone who would like to participate, and we mean it when we say that your presence is welcome and meaningful to us.

Over the summer, Quality Glass has been replacing entryways on the Presbyterian Student Center (three primary entry points and the 5 double doors in the dining room with high efficiency glass and storefront. As of 8/14, the job is essentially finished, with a few minor adjustments outstanding. We are grateful to have improved the efficiency and lessened the environmental impact created in the use of this property.

We are hopeful to complete the replacement of the remaining window walls next summer, which we anticipate costing \$100K+.

To that end, this is our reminder that the NEXT80 Campaign to renovate the Presbyterian Student Center at UGA is ongoing. To date we have received \$350K in gifts and pledges from individuals (~\$275K), congregations + NEGA Presbytery (~\$50K), and family foundations (\$25K).

The 100 Faithful Families initiative of the NEXT80 campaign is nearly 1/4 of the way to completion, with 23 individuals or families pledging \$1,000/year for five years (\$5,000 total). We are grateful to all who have made contributions and pledges so far, and to those who will do so in the coming months. Please consider making a gift or pledge to help Presbyterian Campus Ministry at UGA complete the renewal of our 64-year-old ministry facility. It is a critical piece of the Presbyterian Church's witness in Athens and beyond (www.pscuga.org/next80)
